



### New Tool Helps Manage Opioid Use in Older Adults



A new online tool developed by AHRQ supports efforts by primary care practices and healthcare systems to improve opioid medication management and prevent opioid misuse and opioid use disorder in older adults. The Opioids in Older Adults Compendium allows users to explore potential "high-level changes" that may improve opioid management, including tracking data to provide insights into patients' opioid use, developing workflows to promote team-based care, using shared decision making to provide individualized care, and increasing referrals to nonpharmacologic chronic pain management. Case studies and key activities with tools and resources are provided to support improved care.

# Opioid Use Disorder Screenings & Treatment

#### Medicare Pays for Services

Medicare pays for opioid use disorder (OUD) screenings performed by physicians and non-physician practitioners:

- Required element of the <u>initial preventative physical exam</u> and <u>annual</u> wellness visit
- In physician office and outpatient hospital settings, we'll pay for <u>screening</u>, <u>brief intervention</u>, & <u>referral to treatment services (PDF)</u>:
  - Evidence-based, early intervention approach
  - For non-dependent substance use before patients need more specialized treatment

#### Opioid Treatment Programs: New Information for 2024

Visit Opioid Treatment Programs (OTP) for CY 2024 updates, including:

- <u>Physician Fee Schedule</u> final rule extends the flexibility through the end of CY 2024 to provide periodic assessments via audio-only when video isn't available, when authorized by SAMHSA and DEA
- Hospital Outpatient Prospective Payment System and Ambulatory Surgical
   Center Payment System final rule establishes a weekly payment adjustment for an Intensive Outpatient Program (IOP) provided by an OTP for opioid use disorder treatment; the IOP service:
  - Must be medically reasonable and necessary
  - Can't duplicate any service paid for under any bundled payments billed for an episode of care in a given week

Public Participation: The Resource Fair is now open to the public, offering a greater opportunity to provide resources to everyone.


### **OKShine: Health Information Exchange**



Did you know Oklahoma has a statewide health information exchange (HIE)? Did you know that if you are a licensed health care provider, including SUD or behavioral health providers, that you are eligible to sign up for the HIE?

The HIE allows health information to flow seamlessly to and from providers in Oklahoma which allows us to enhance health care delivery. It creates the connection to allow appropriate and secure access to clinical data for safe, more timely, efficient, effective, equitable, patient-centered care. SUD and behavioral health providers may find the HIE particularly useful to gain a "whole picture" of a patient's health to aid in the reduction of risk and adverse side effects.

Want to sign up for the state HIE, OKSHINE? Follow this 3 step process:

- Apply to participate in Oklahoma's Health Information Exchange and obtain an order form.
- Complete an application through the office of the state coordinator to recieve assistance with one-time connection fee costs. Subscription fees are not included.
- Recieve approval from the office of the state coordinator.

The Certified Peer Recovery Support Specialist (PRSS) fulfills a unique role in the support of and recovery from mental health issues and substance use disorders. A PRSS is a person in recovery from a mental health diagnosis and/or substance use disorder, who has been trained to work with others on their individual road to recovery. This training incorporates the PRSS's recovery experience as a means of inspiring hope in those they serve, as well as providing a positive role model to others. # Opioid Settlement Funding Spending Discretion



Many of the lawsuits filed against companies involved in the opioid overdose crisis have now been resolved. As a result, over \$30 billion in funding will be coming to states, cities, and counties over the next 18 years, with the first payments arriving in 2022. The agreements place limitations on how states and local communities can use the money with most of it being used to address the opioid overdose epidemic. To help your state and local jurisdictions use the money wisely, you can share the Primer on Spending Funds from the Opioid Litigation with your government officials to encourage appropriate use on this funding. The guide shares information on how to invest in evidence-based programs and services to address the opioid epidemic.
